Qualitative analysis of Criterion 6

Vaagdevi College of Pharmacy operates under the governance and leadership of the Viswambhara Educational Society, comprising of professional experts and professors from various fields of pharmacy education. The governing body, includes the Secretary and Correspondent, Chief administrative officer, university nominees, Industrial experts, Directors, and Principal who ensure the institution's adherence to its vision and mission.

The governing body plays a role in setting guidelines for academic growth and sustaining the institution's quality policy. The Principal implements policy decisions through decentralized processes and committees, with short-term and long-term plans formulated to achieve the stated mission.

Few employee welfare measures are in place such as group insurance, medical leaves, maternity leave, advance salaries and fee concession for staff children. Teaching and non-teaching staffs are encouraged to attend professional/administrative development programmes.
