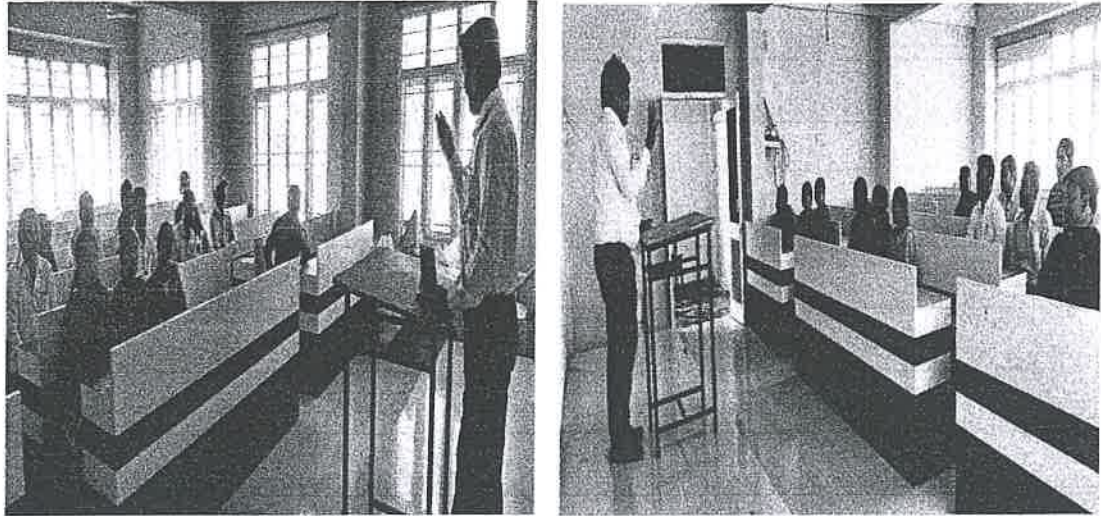



Fig.1. Training on Disciplinary Procedures (15-11-2022 TO 19-11-2022) by Principal and Physical Director, VCOP to the non-teaching staff

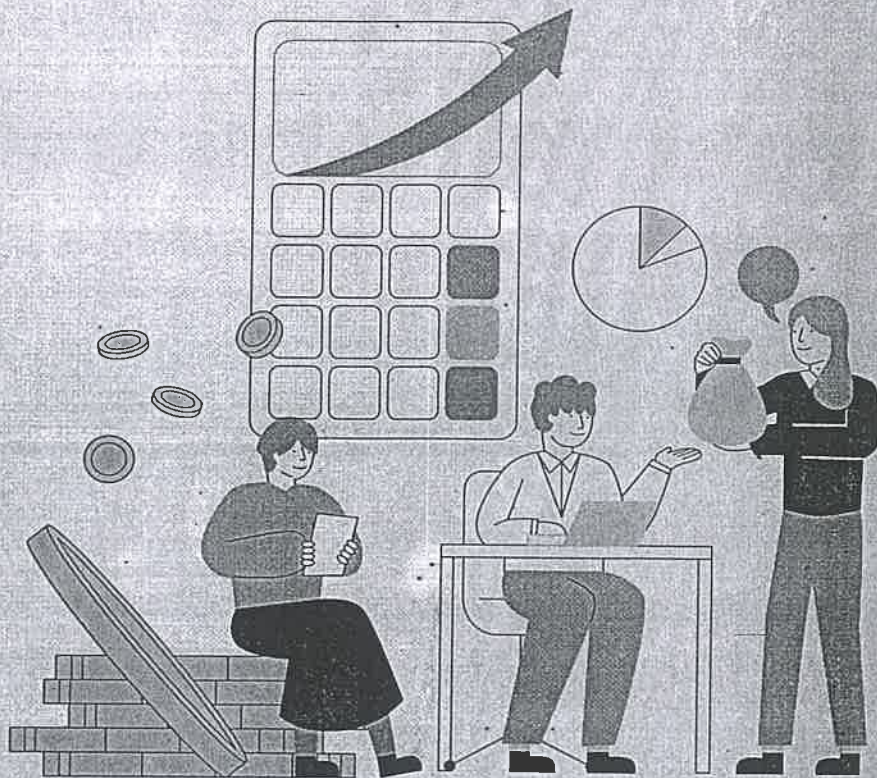

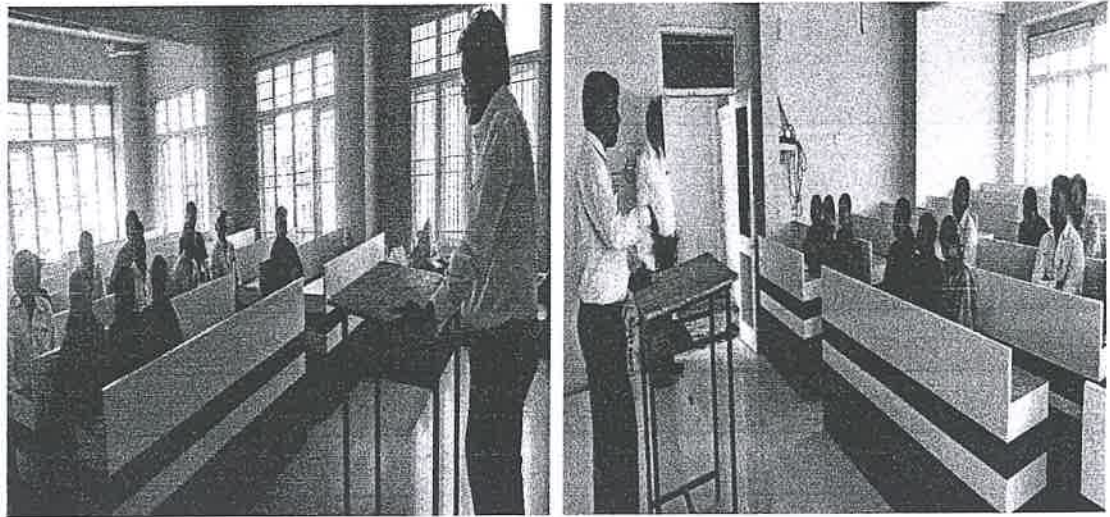


Fig.1. Training on Best practices in office administration (14-03-2023 TO 18-03-2023) by Principal and Physical Director, VCOP to the non-teaching staff
