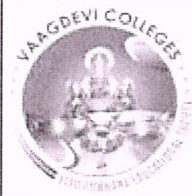

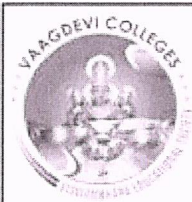

Proceedings of the meeting:

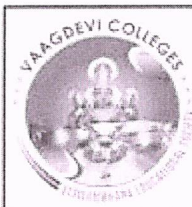

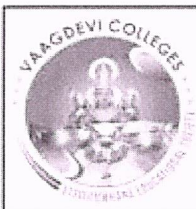

We got MoU in 2017-2018 year with **Vaageeshwary college of Pharmacy** and **Vaagdevi Institute of Pharmaceutical sciences** for the duration of 3 years (09/08/2017 to 14/08/2020) and for 6years (19/08/2017 to 19/08/2023) to do the collaborative research respectively. We also got the MoU with **Manisha Neuro Psychiatric Clinic and Counselling Centre** for 5 years (31/01/2018 to 31/01/2023) to get the training of Pharm. D. students.


The council also suggested to promote hands on training on usage of equipment for lab technicians.

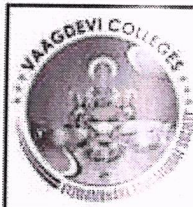
Agenda item No.7: Extra-Curricular Activities and Co-Curricular Activities

Agenda item No. 9. Functioning of various committees

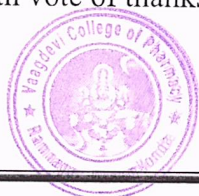
The council members were satisfied with the performance of various committees like Examination committee, Anti-ragging & Internal complaint committee, Cultural and Sports committees.
