The council verified the utilized budget for the year 2018-2019 and approved the budget for the year 2019-2020.

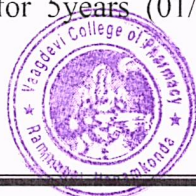

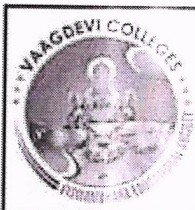
Agenda item No. 6: Industry institute interaction and MoUs

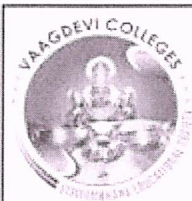
Agenda item No. 8: Placements

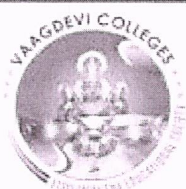
