We have updated the library and Lab equipment and computers with the latest peripheral, with unlimited access of internet and LAN facility.


**Agenda item No.4. Development of Library in automation Process**

**Agenda item no. 12. Functioning of various committees**

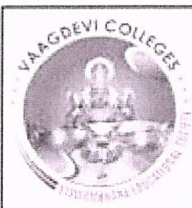
The council members were satisfied with the performance of various committees like NSS (Vaag Anubandh), Research & Development (VIPRA), Electoral Littracy Club etc.

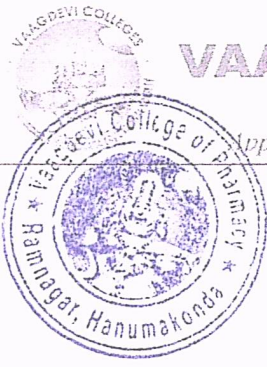
