

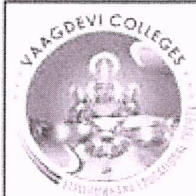

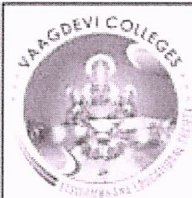

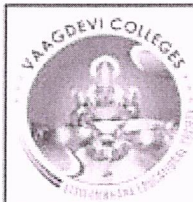

Sri. Ch. Narasimha Reddy, Chairman, presided over the meeting. The items as per agenda note were taken for discussion and ratification.

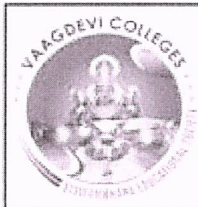

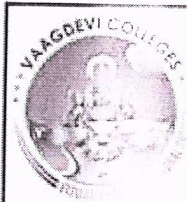
#### **Agenda item No. 4. Budget proposals for the academic year 2021-2022**

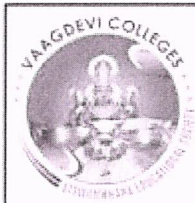
**Agenda item no. 8. Placements**

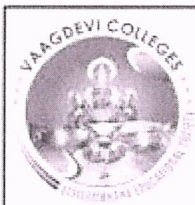
**Agenda item No.11: Providing advanced clinical Database to Pharm D students.**

The meeting closed at 05.00 PM with the vote of thanks by Member Secretary.

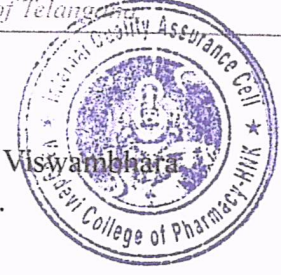
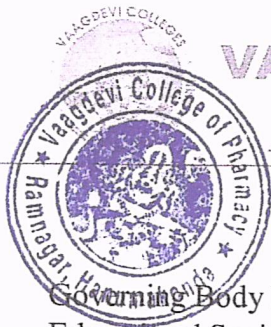
